Data current as of June 11, 2018

At this time last year, there were two universal truths in residential real estate across the country. Whether or not sales were up in year-over-year comparisons, the market was assuredly active, and, thus, overall inventory was trending downward compared to the year before. That remained the case for the entirety of 2017, and that refrain sounds entirely familiar for the duration of 2018.

In the Charlotte region, for the week ending June 2:

- New Listings decreased 6.0% to 1,250
- Pending Sales increased 15.6% to 1,151
- Inventory decreased 17.6% to 9,446

For the month of May:

- Median Sales Price increased 9.5% to \$245,000
- List to Close decreased 9.3% to 88
- Percent of Original List Price Received increased 0.2% to 97.5%
- Months Supply of Homes for Sale decreased 20.9% to 2.3

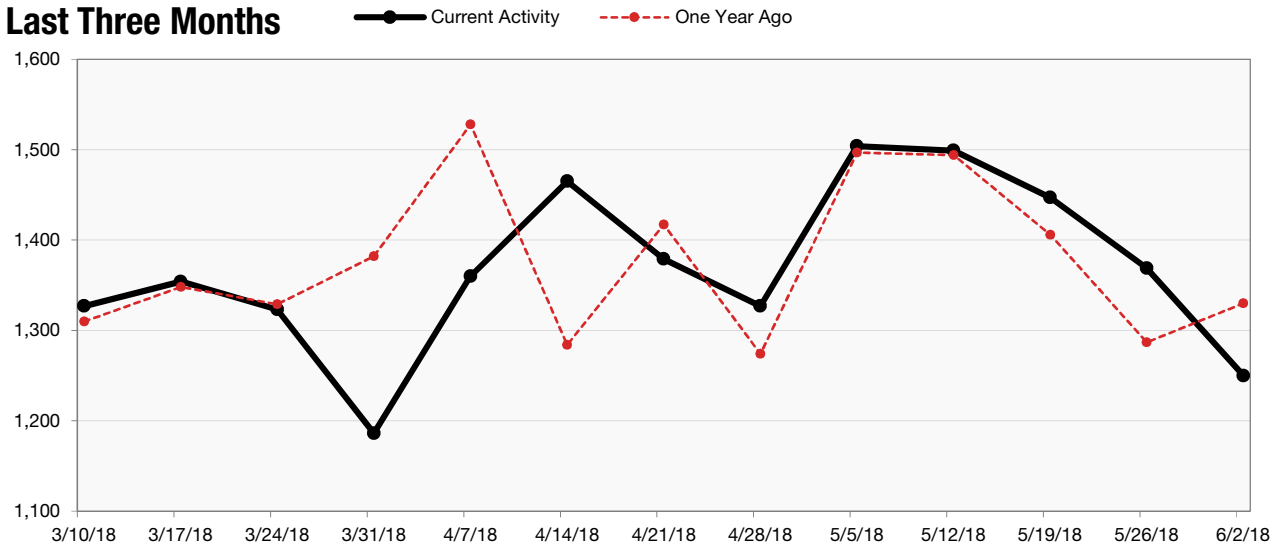

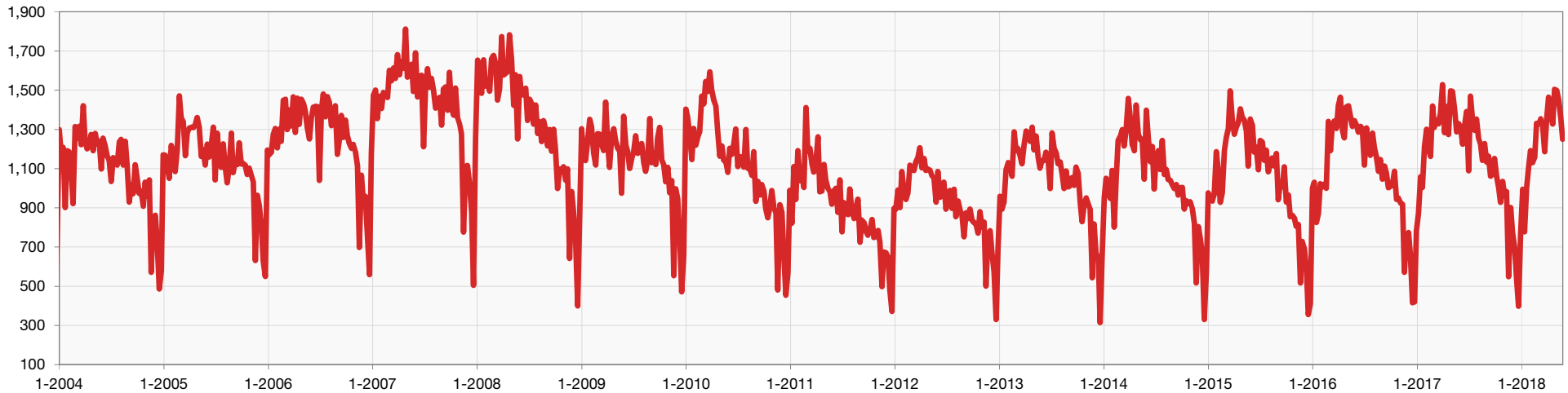

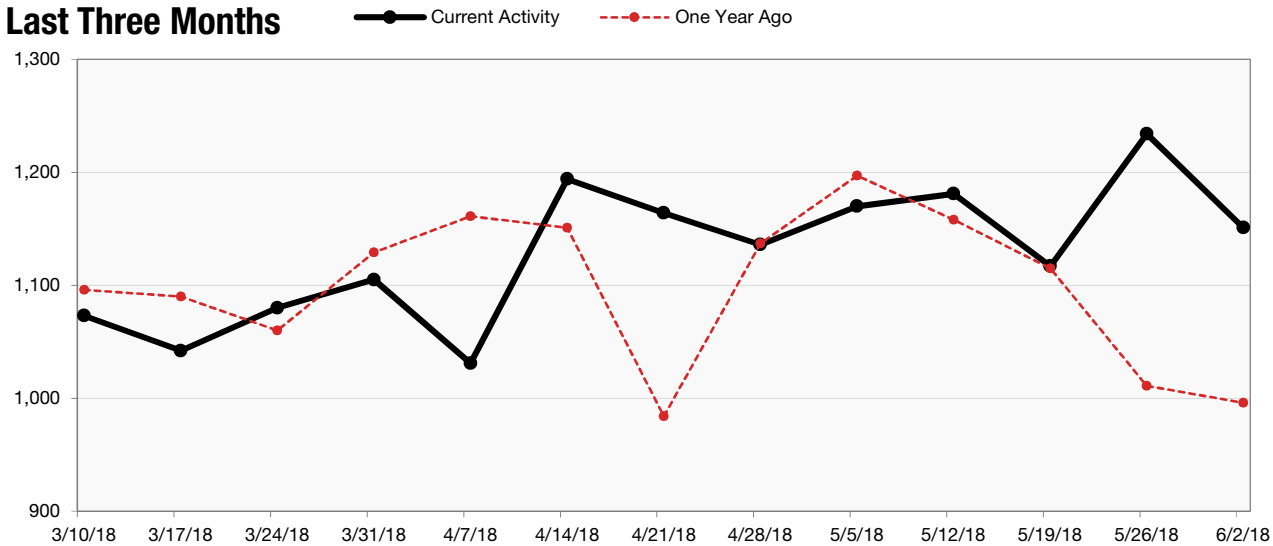

Pending Sales



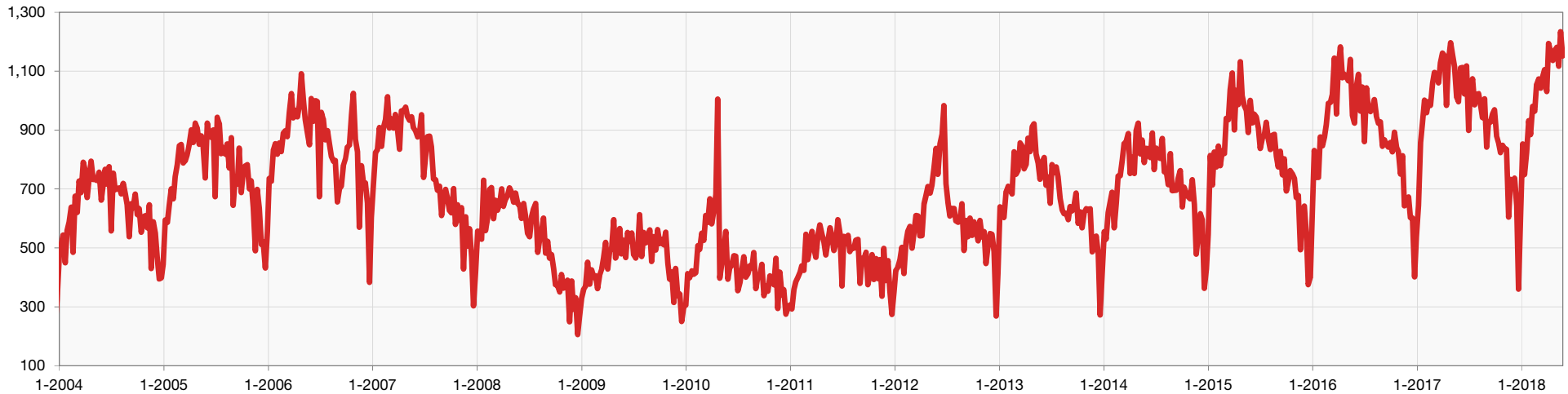

Historical Pending Sales Activity



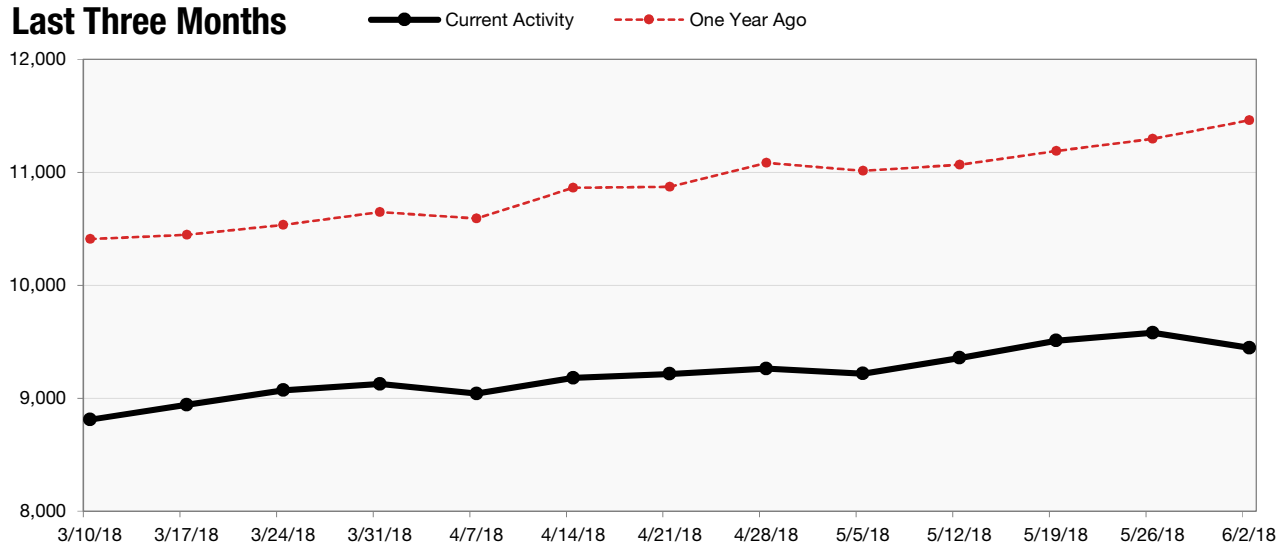

The number of properties available for sale in active status at the end of a given week.

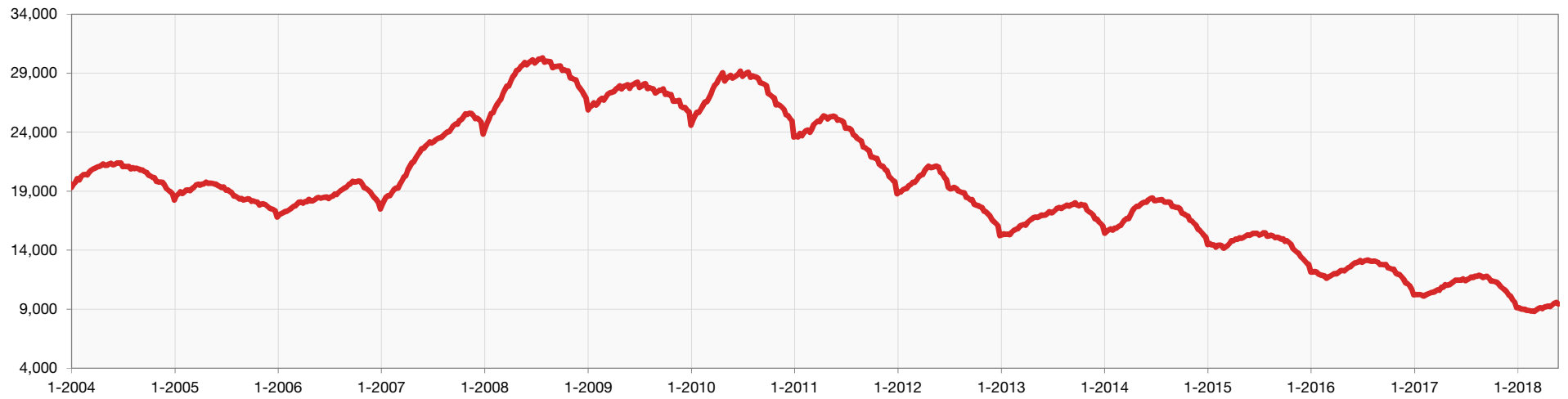

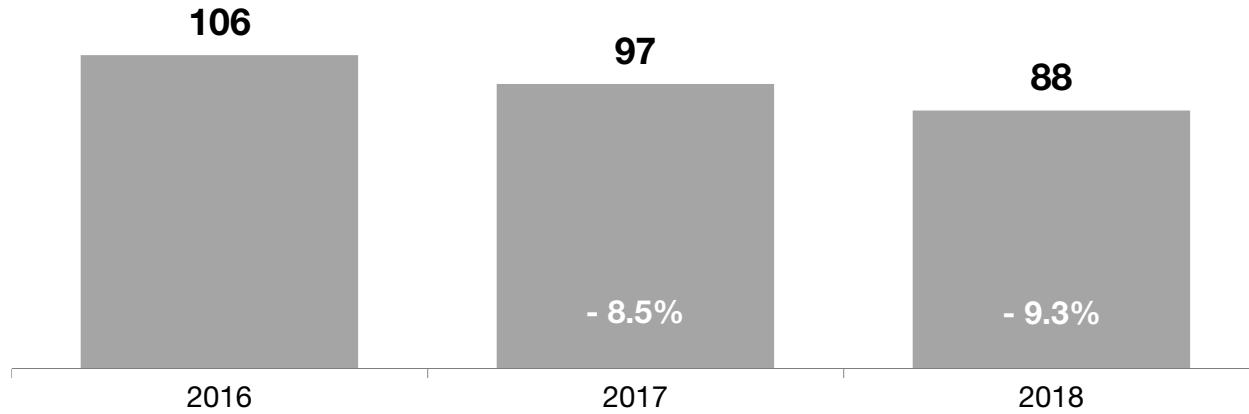

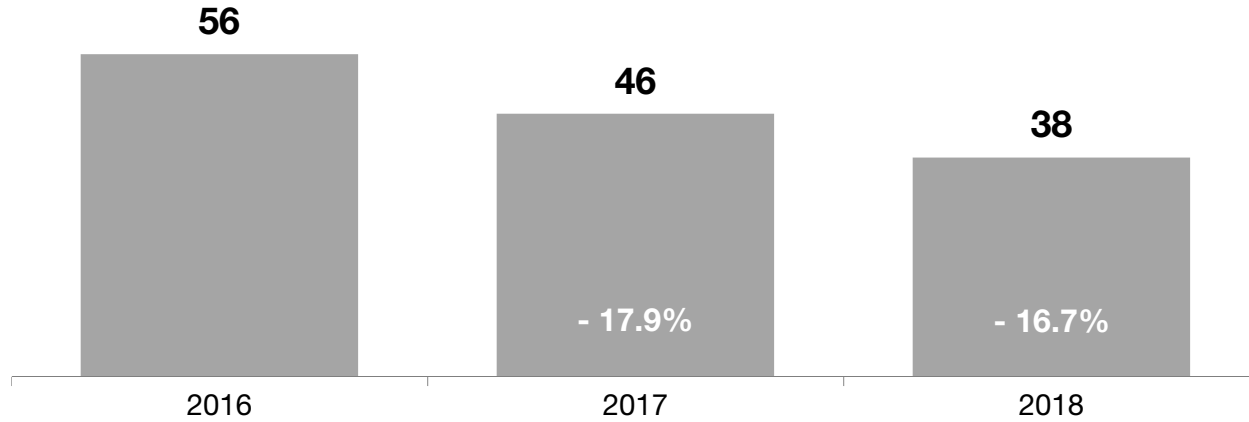

Days on Market (DOM) tracks the days on market for a property specific to the MLS number. DOM accrues for "Active" and "Under Contract-Show" statuses. DOM does not include any days that the listing is in "Under Contract-No Show," "Temporarily off Market," "Closed/Sold," "Expired" and "Withdrawn" statuses.

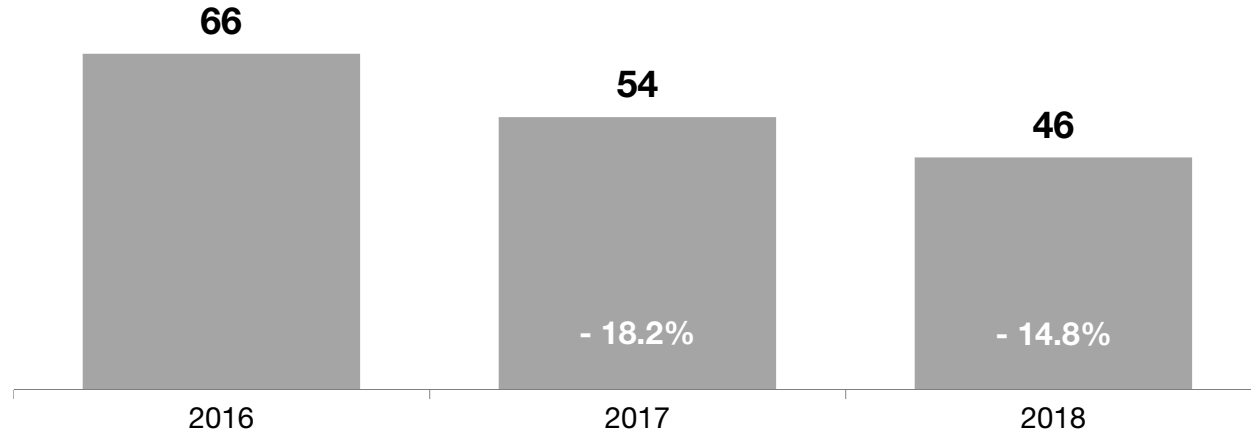

Cumulative Days on Market



Cumulative Days on Market (CDOM) functions like Days on Market (DOM); except CDOM tracks the DOM for a property over multiple listings on the property. When a new listing is entered, the CDOM only resets to zero if the previous listing closed (sold) or if the previous listing has been off the market (expired or withdrawn) for more than 90 days.

Historical Cumulative Days on Market



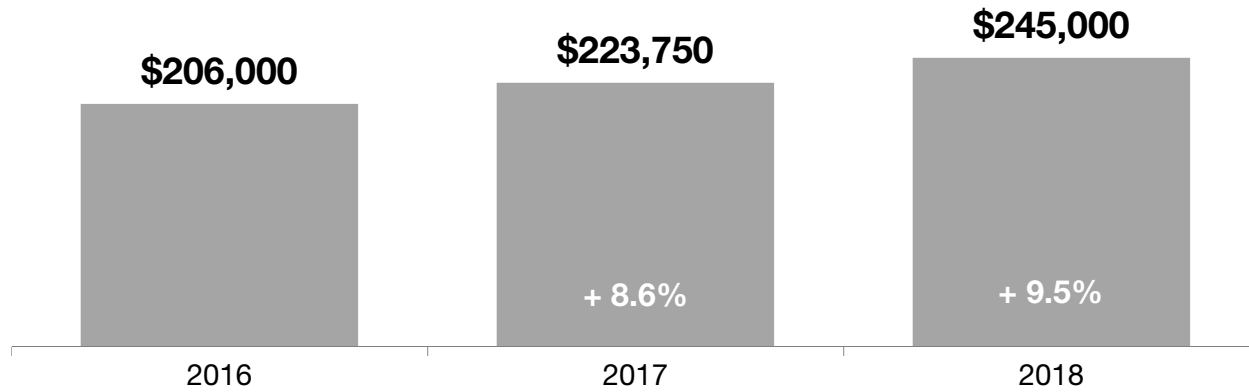

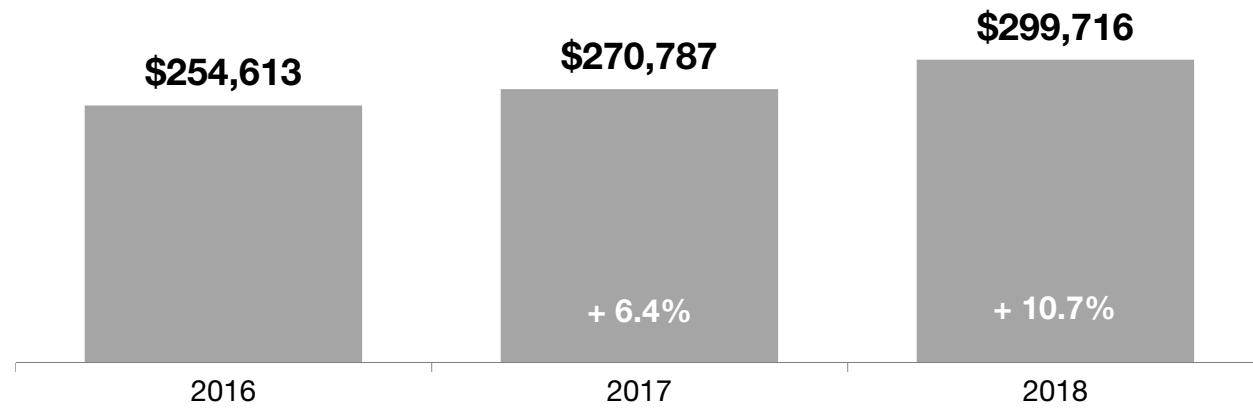

Average sales price for all closed sales, not accounting for seller concessions, in a given month.

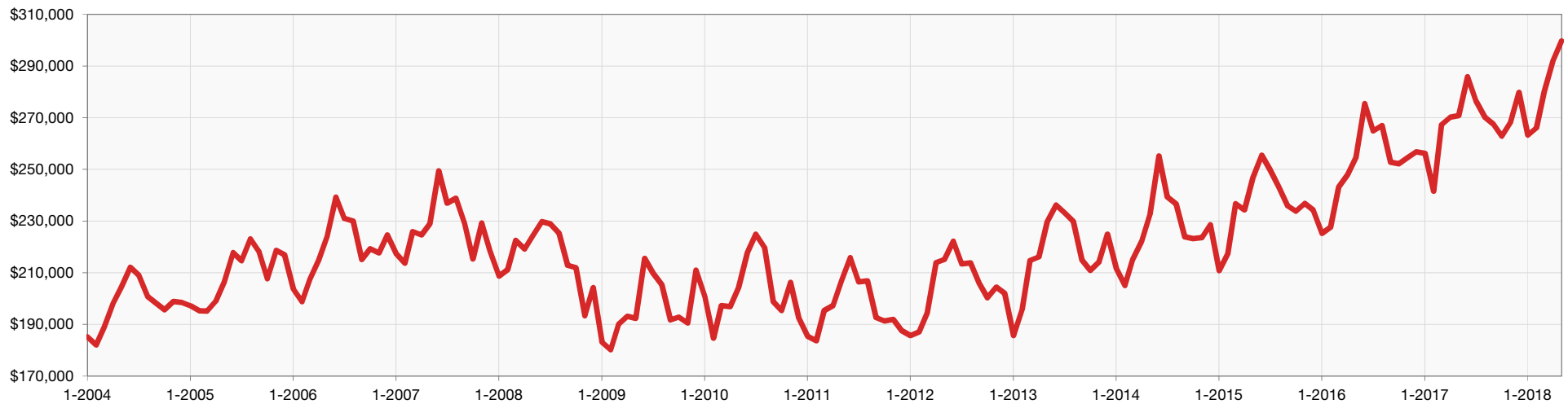

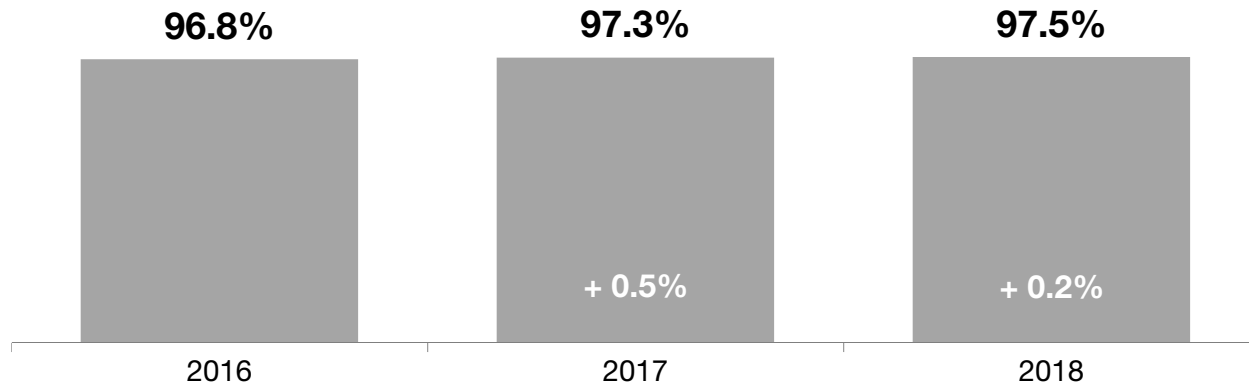

Historical Percent of Original List Price Received



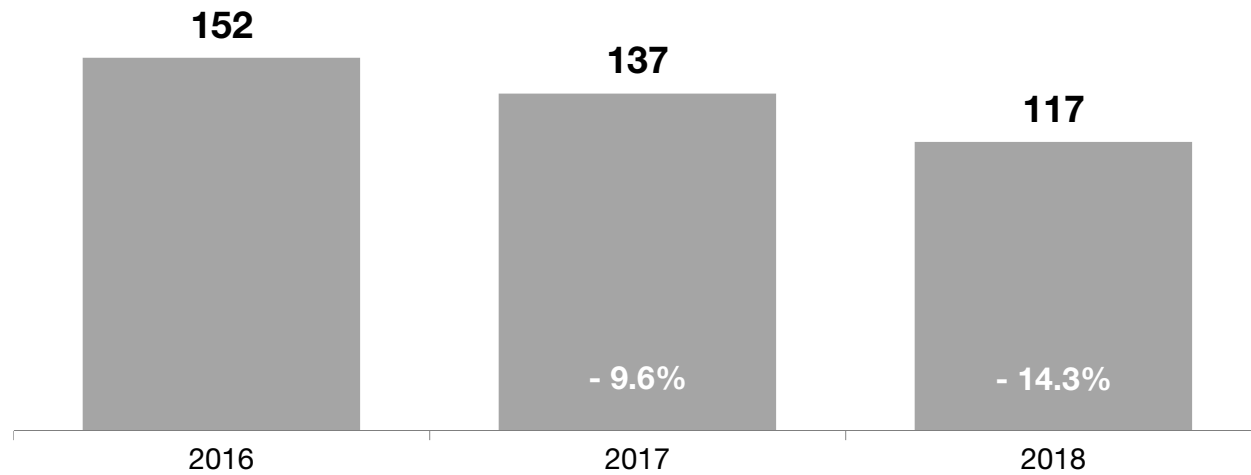

Housing Affordability Index



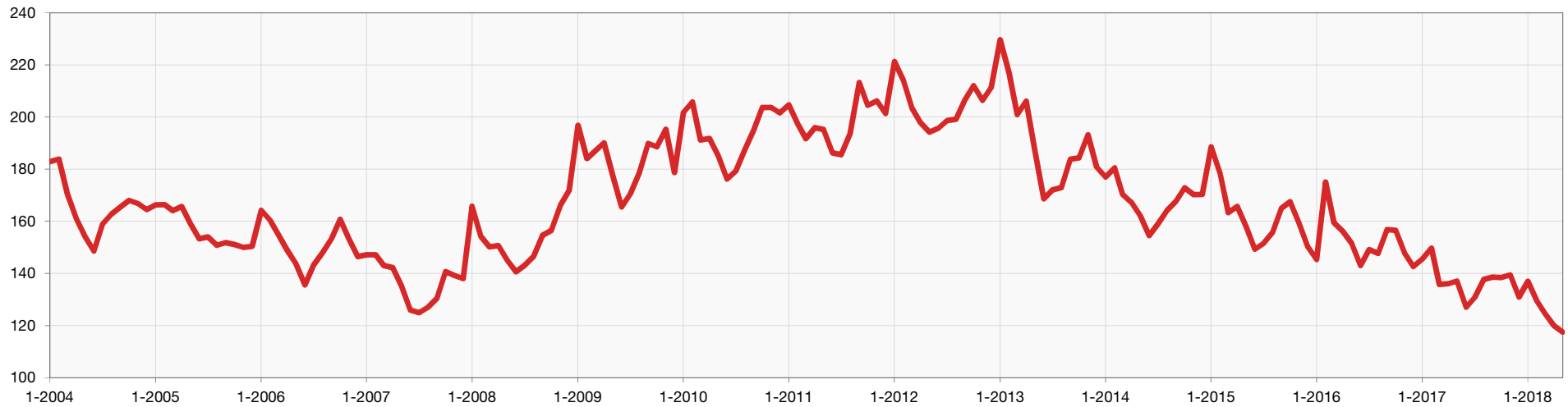

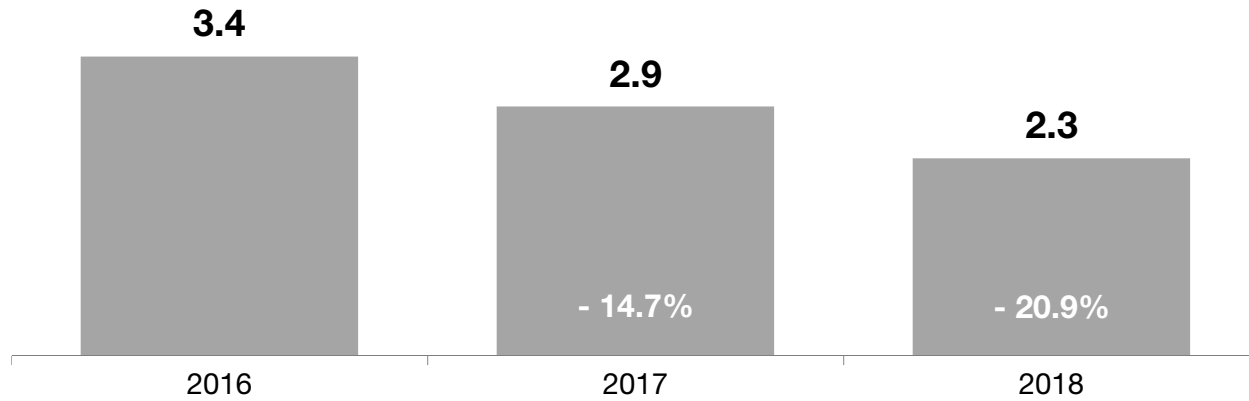
