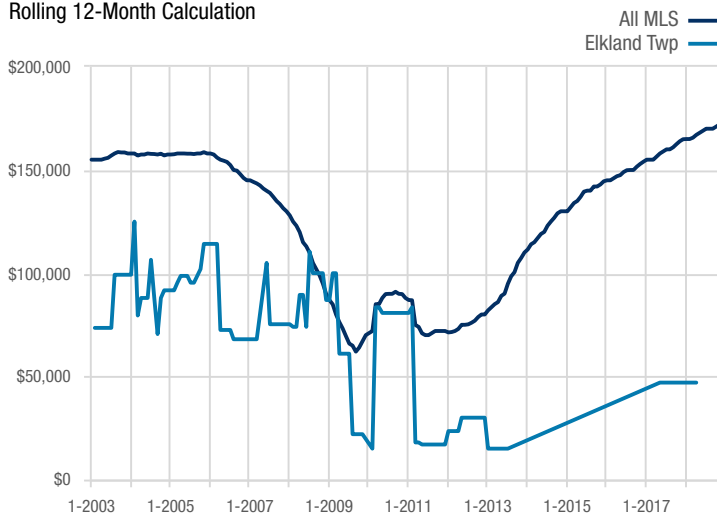

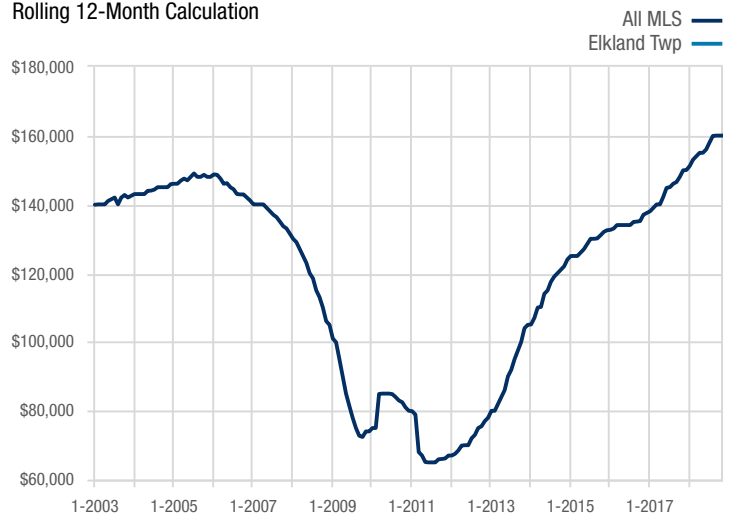
Median Sales Price - Residential
