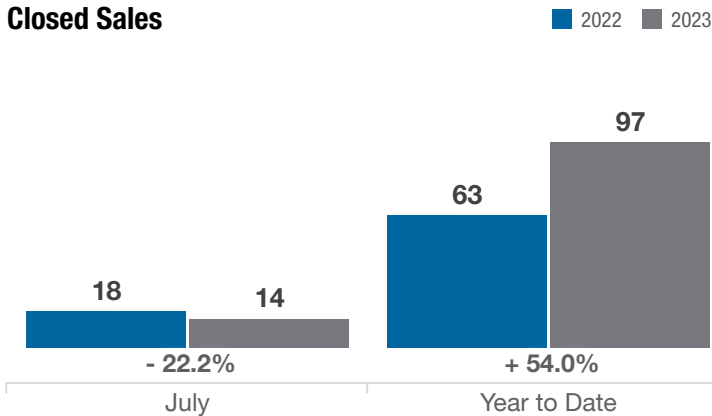

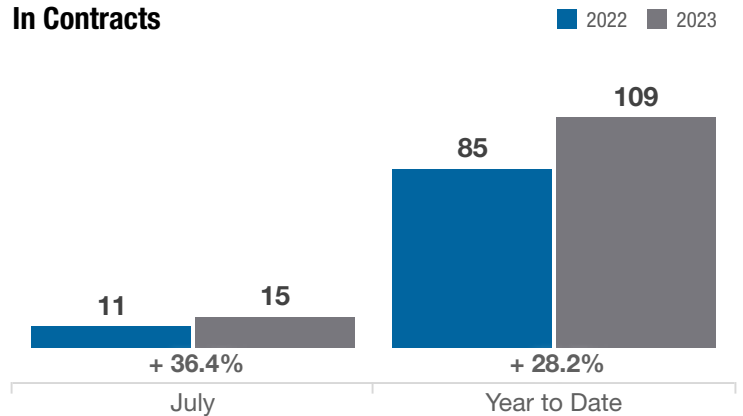

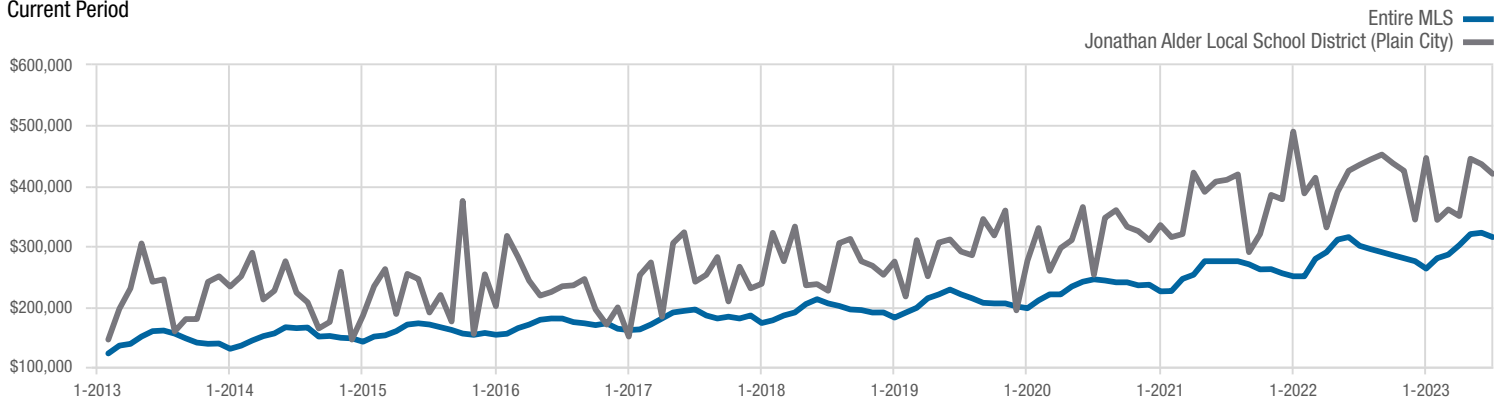

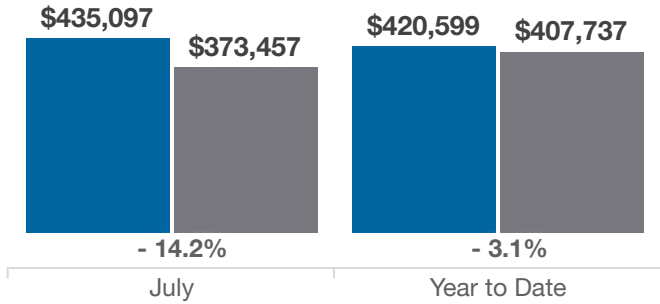

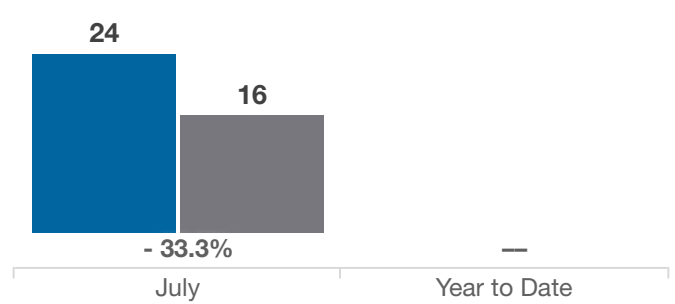
Average Sales Price

■ 2022 ■ 2023



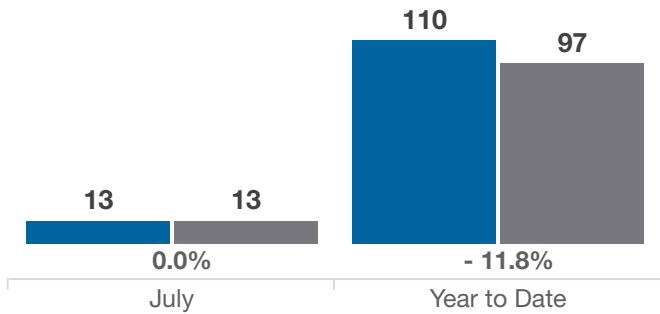
Inventory of Homes for Sale

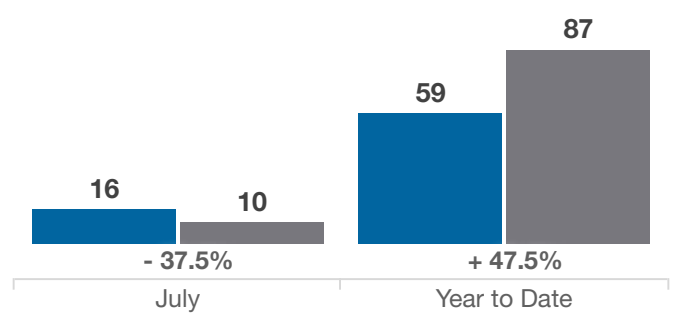
New Listings

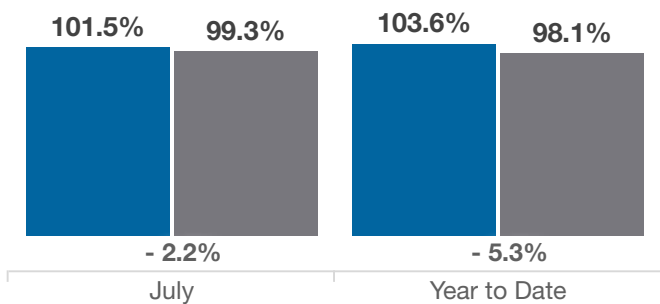
Single Family Sales
