Data current as of September 19, 2022

Home prices are softening in many markets across the country, as sales slow under the weight of higher mortgage interest rates and elevated sales prices. With rates now double what they were a year ago, many experts believe additional price declines are on the horizon. According to Moody's Analytics, more than half of the nation's largest regional housing markets were overvalued by more than 25% in the second quarter of 2022, making these areas at risk of price declines of 15% - 20% over the next 12 - 18 months.

In the Charlotte region, for the week ending September 10:

- New Listings decreased 17.9% to 1,050
- Pending Sales decreased 16.7% to 916
- Inventory increased 30.5% to 7,049

For the month of August:

- Median Sales Price increased 16.7% to \$388,510
- List to Close increased 7.4% to 73
- Percent of Original List Price Received decreased 3.0% to 98.5%
- Months Supply of Homes for Sale increased 45.5% to 1.6

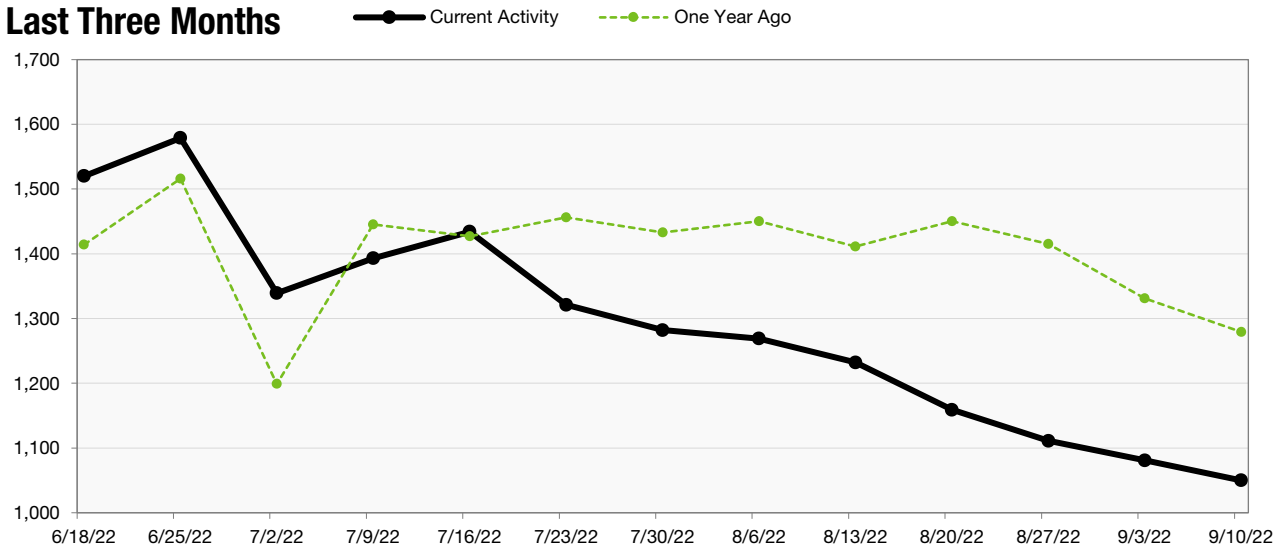

A count of the properties that have been newly listed on the market in a given week.

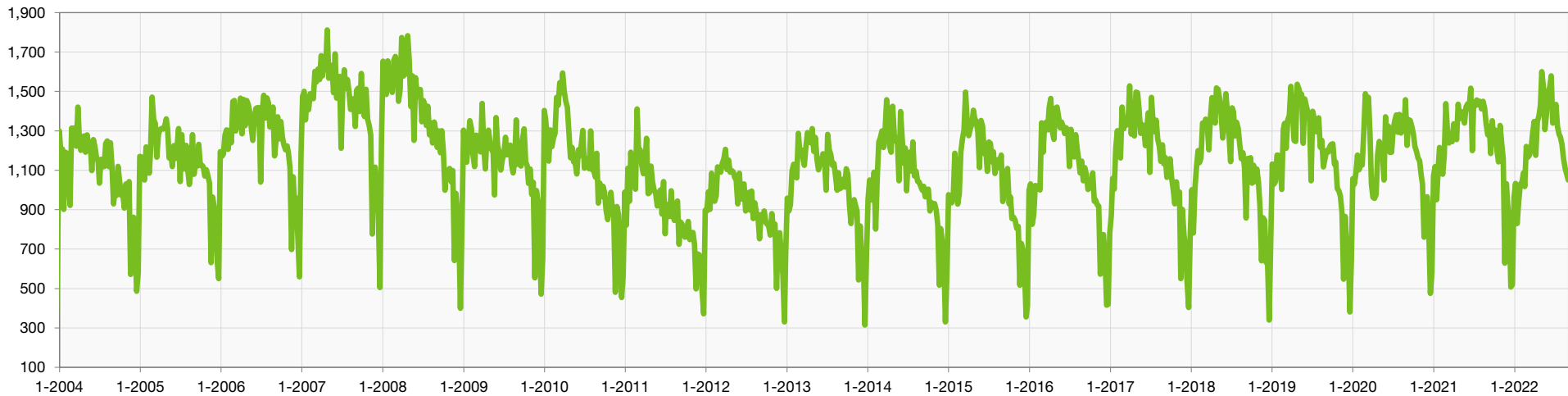

Historical New Listing Activity



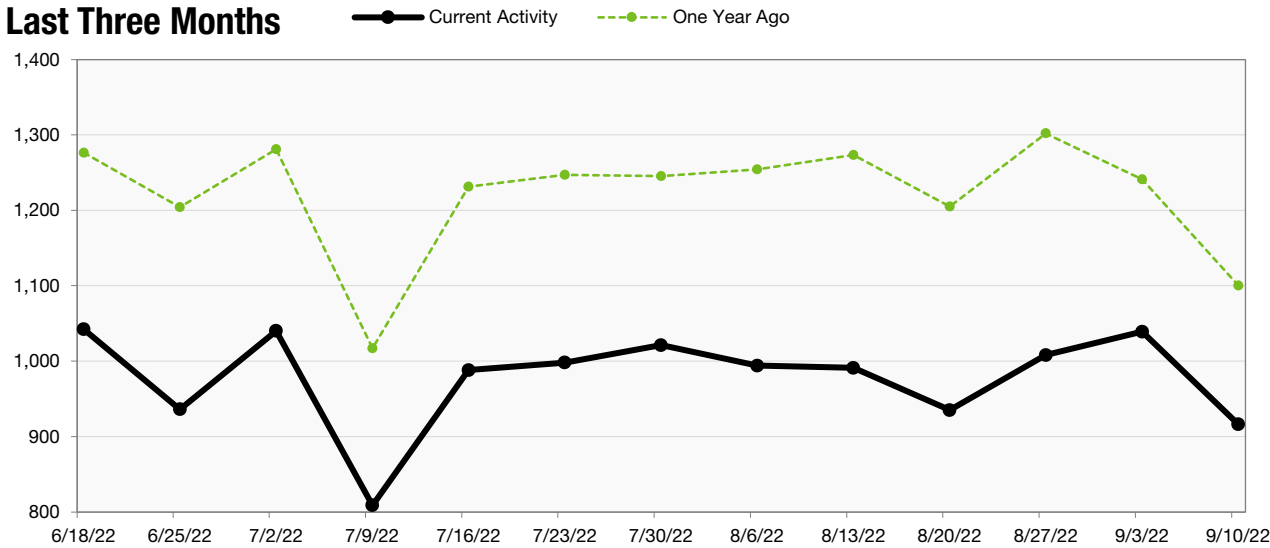

A count of the properties on which contracts have been accepted in a given week. Pending contracts include "Under Contract-Show" and "Under Contract-No Show" statuses.

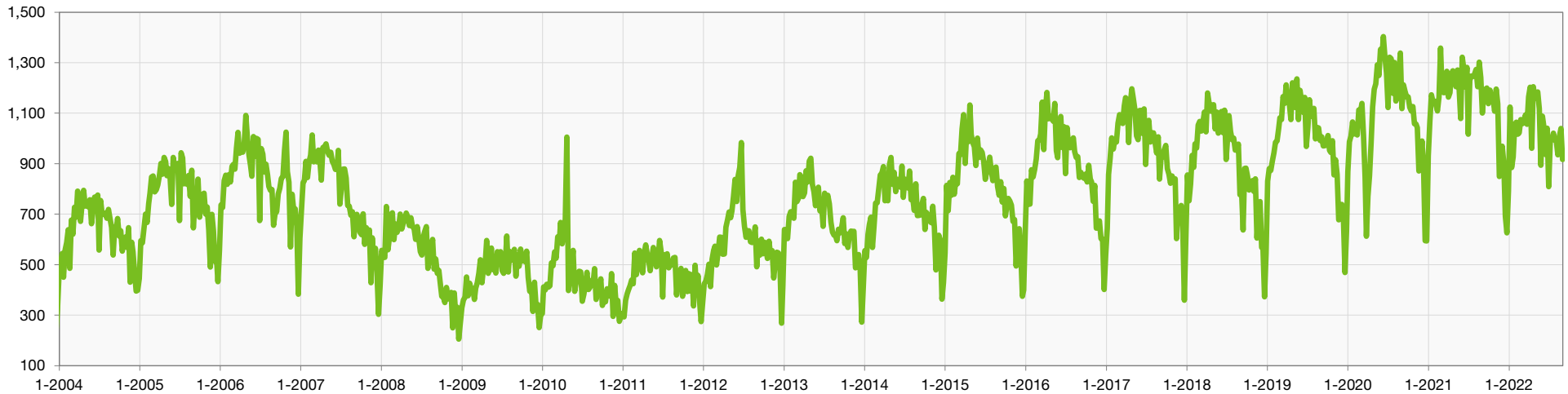

Historical Pending Sales Activity



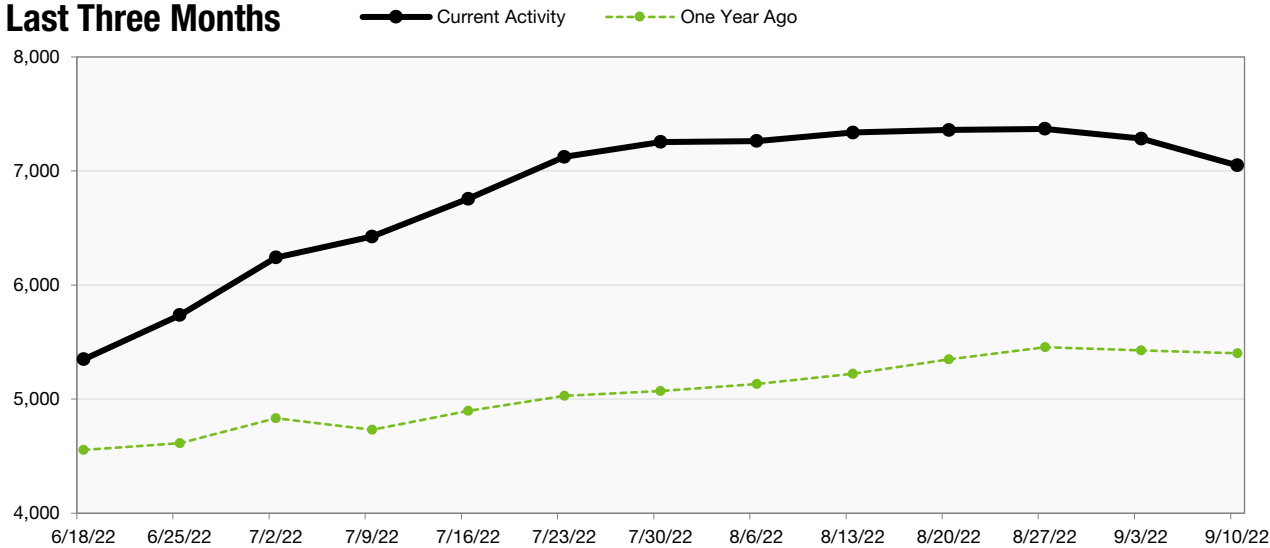

Historical Inventory Activity



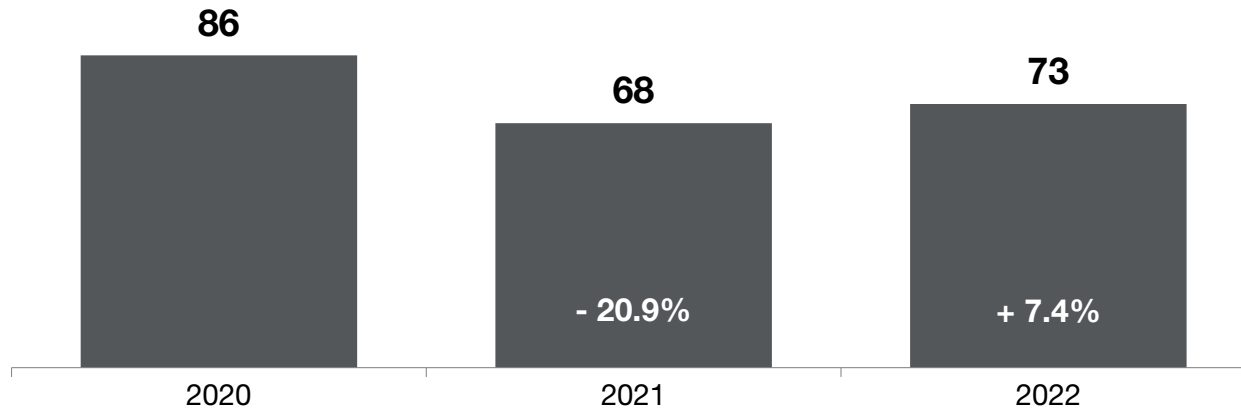

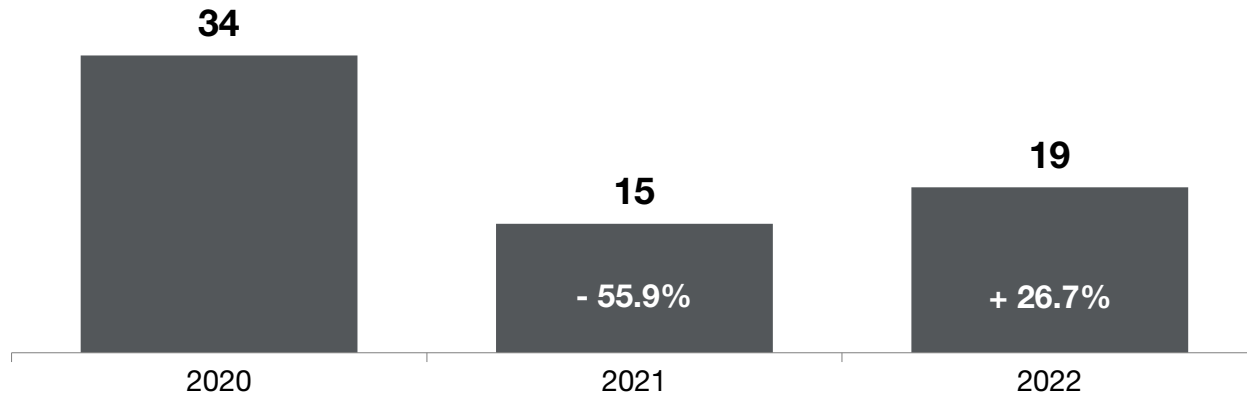

Days on Market



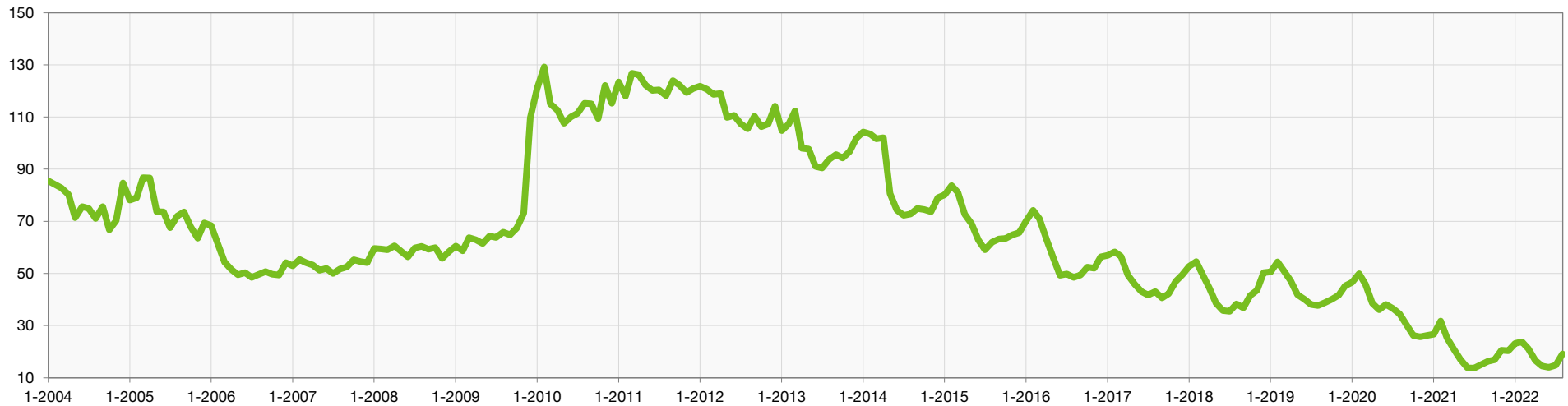

DOM does not include any days that the listing is in "Under Contract-No Show," "Temporarily off Market," "Closed/Sold," "Expired" and "Withdrawn" statuses.

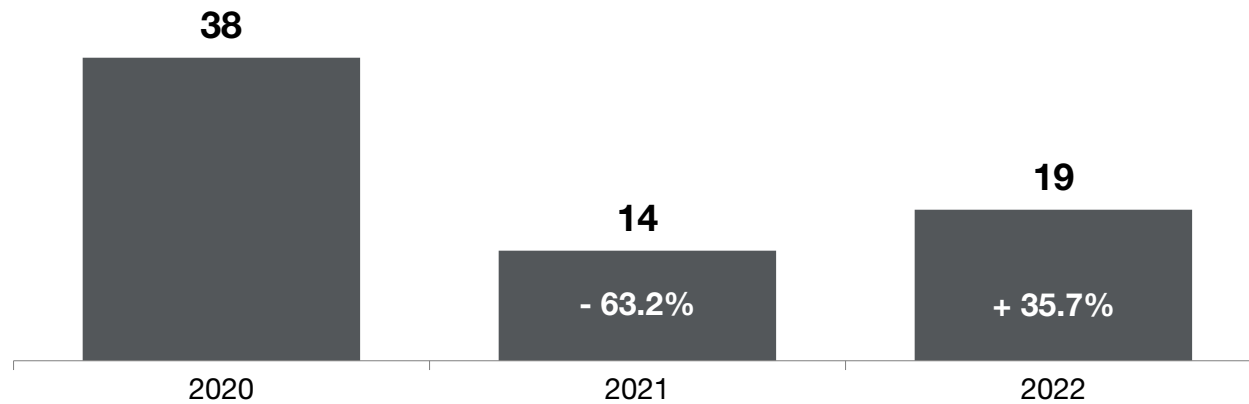

Cumulative Days on Market

Cumulative Days on Market (CDOM) functions like Days on Market (DOM); except CDOM tracks the DOM for a property over multiple listings on the property. When a new listing is entered, the CDOM only resets to zero if the previous listing closed (sold) or if the previous listing has been off the market (expired or withdrawn) for more than 90 days.

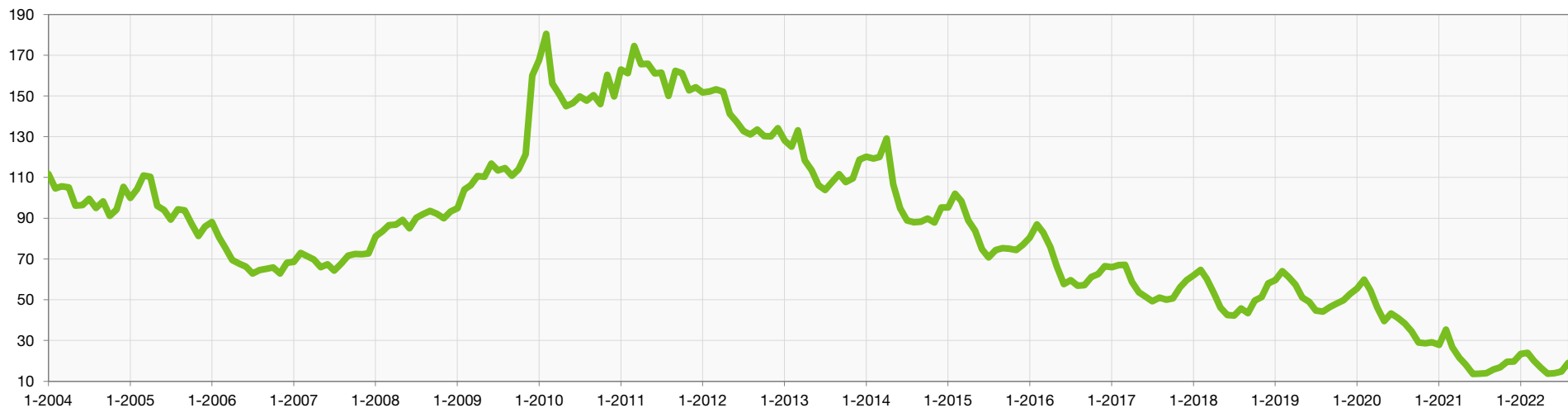

Historical Cumulative Days on Market



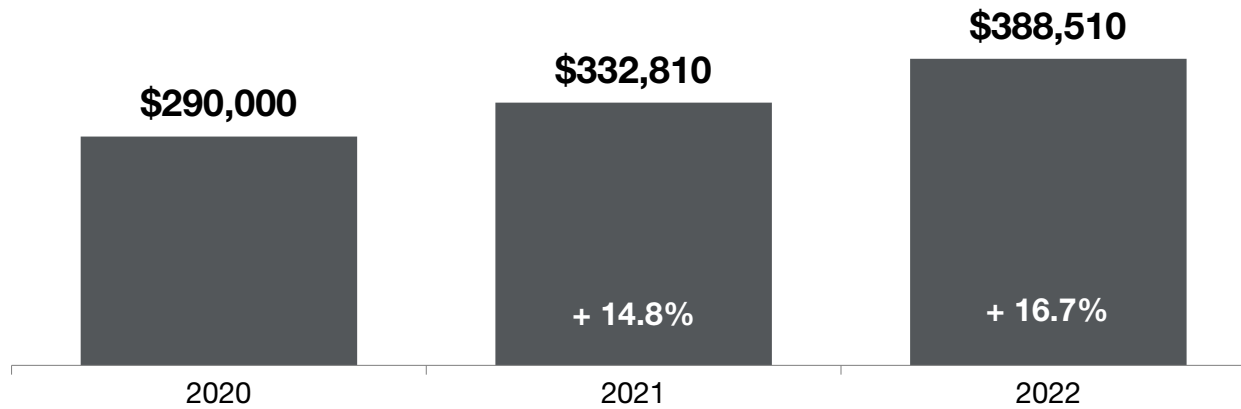

Median price point for all closed sales, not accounting for seller concessions, in a given month.

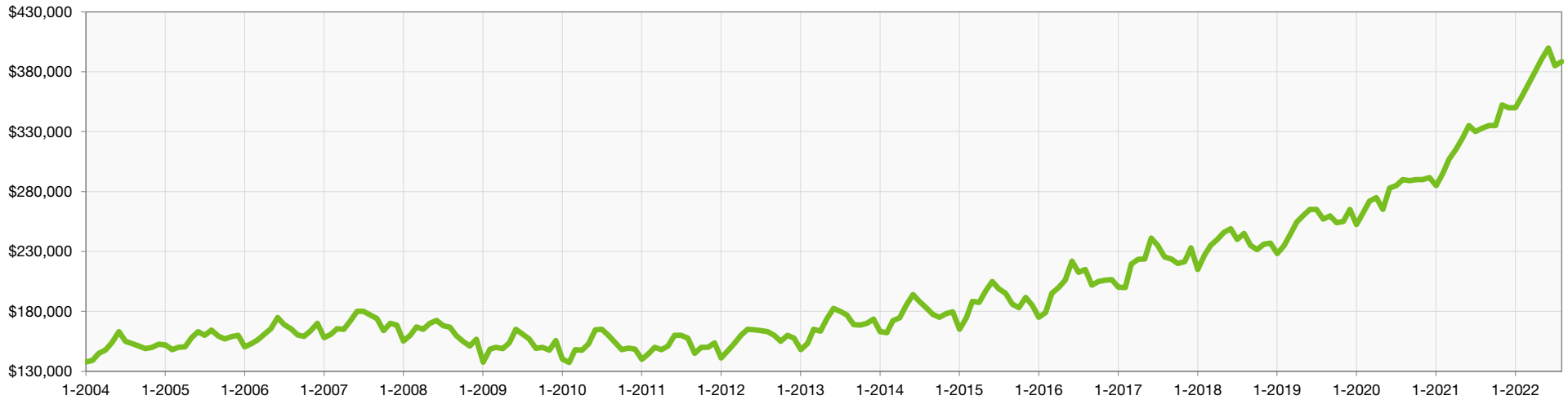

Historical Median Sales Price



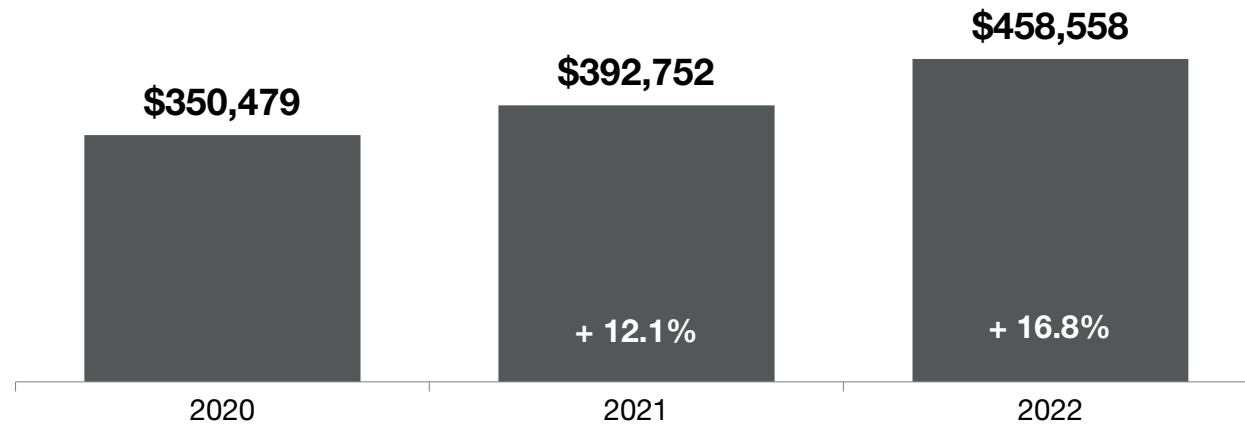

Average sales price for all closed sales, not accounting for seller concessions, in a given month.

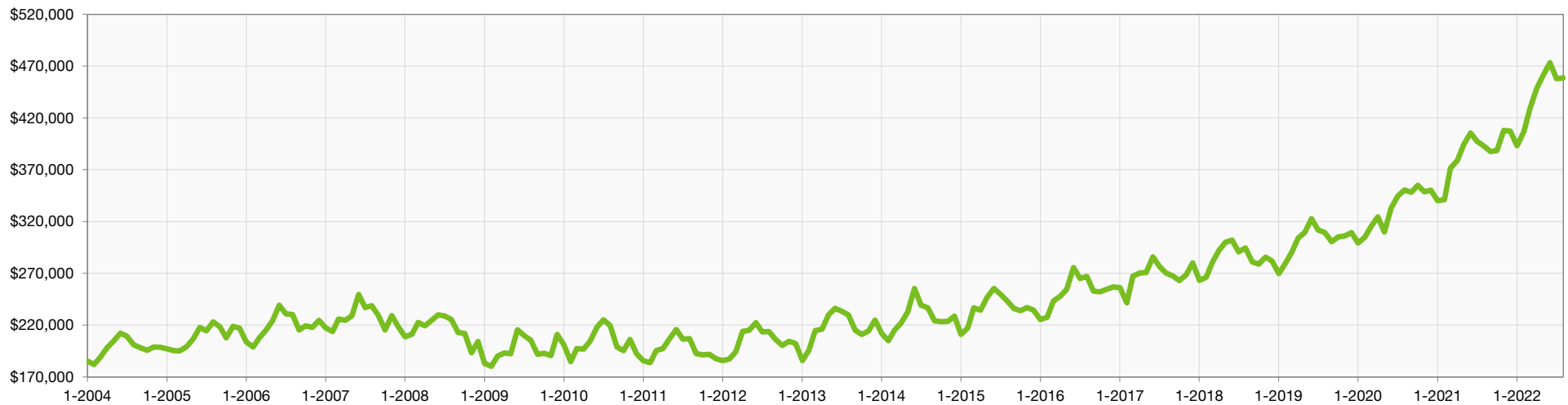

Historical Average Sales Price



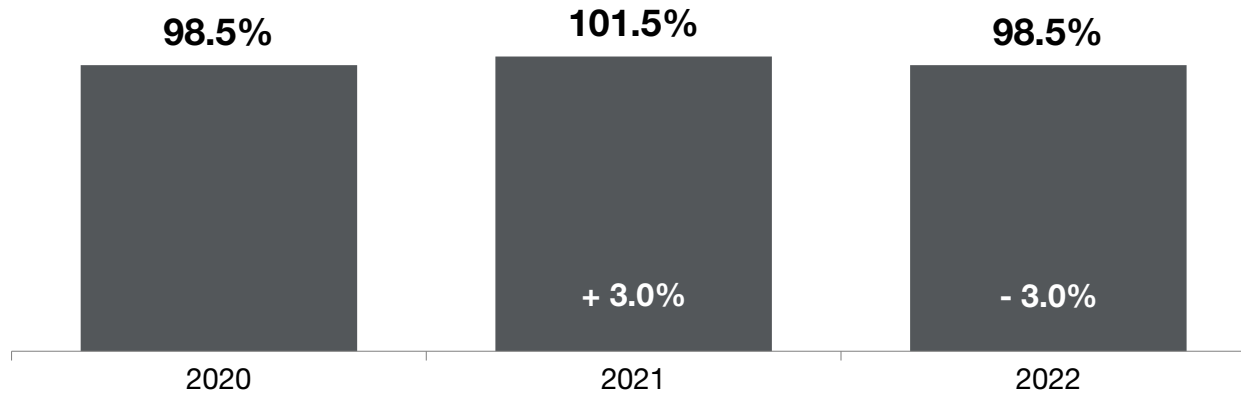

Historical Percent of Original List Price Received



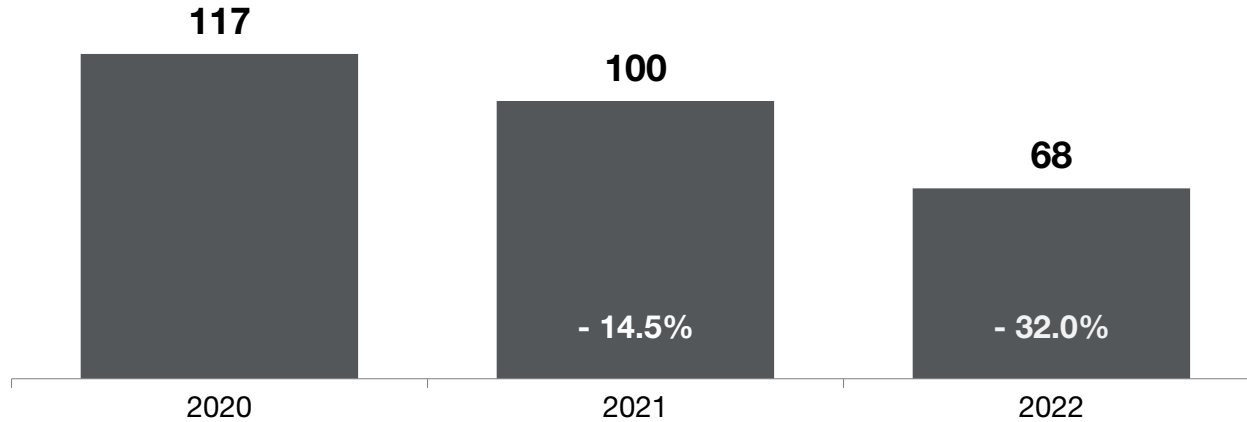

Housing Affordability Index



This index measures housing affordability for the region. For example, an index of 120 means the median household income was 120% of what is necessary to qualify for the median-priced home under prevailing interest rates. **A higher number means greater affordability.**

Historical Housing Affordability Index



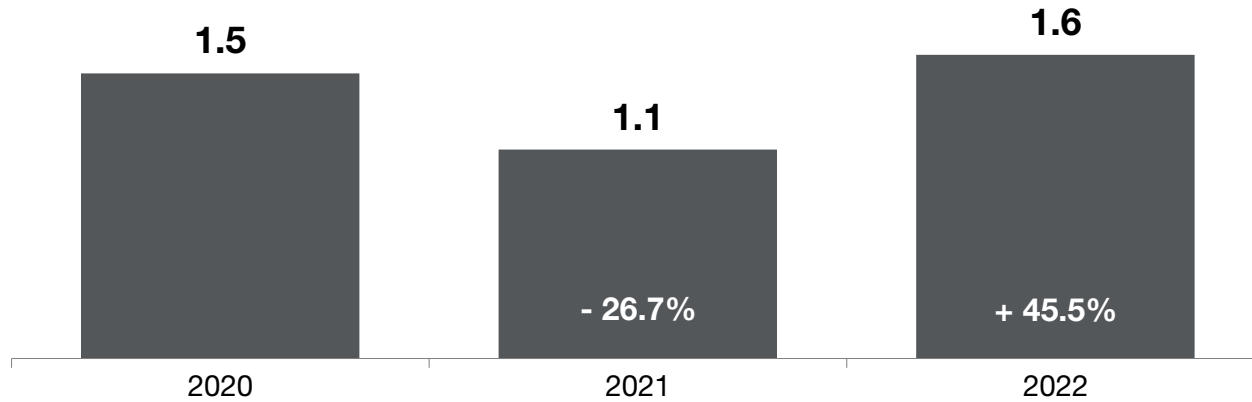

The months supply of homes for sale at the end of a given month, divided by the average monthly pending sales from the last 12 months.

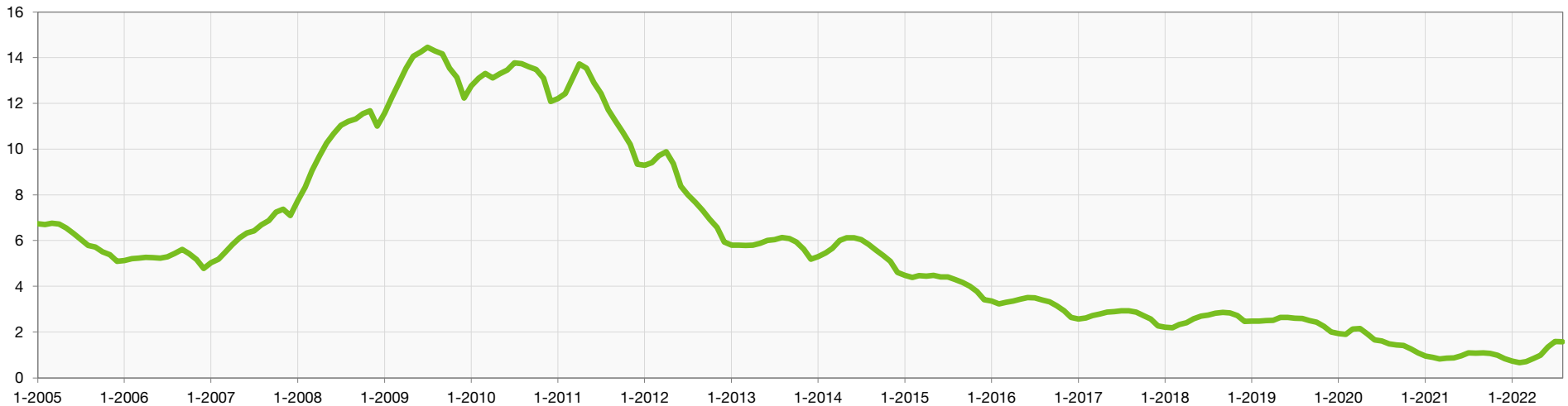
