Data current as of October 24, 2022

Median national rents fell slightly to \$1,759 in September, marking the second consecutive month rents have dropped, according to a recent report from Realtor.com. Although median rents remain 7.8% higher than a year ago, it represents the smallest year-over-year increase and the slowest annual rate of growth since June 2021, suggesting the rental market may be cooling after the record-breaking pace of the last two years.

In the Charlotte region, for the week ending October 15:

- New Listings decreased 21.9% to 1,019
- Pending Sales decreased 30.4% to 830
- Inventory increased 38.6% to 7,514

For the month of September:

- Median Sales Price increased 13.4% to \$380,000
- List to Close increased 12.9% to 79
- Percent of Original List Price Received decreased 3.8% to 97.2%
- Months Supply of Homes for Sale increased 54.5% to 1.7

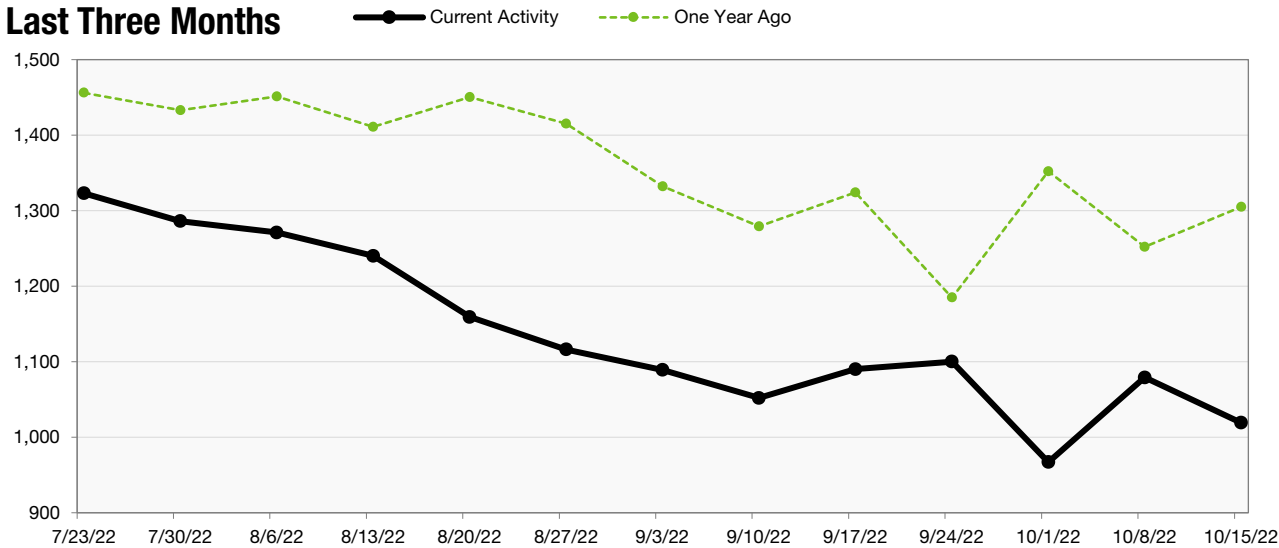

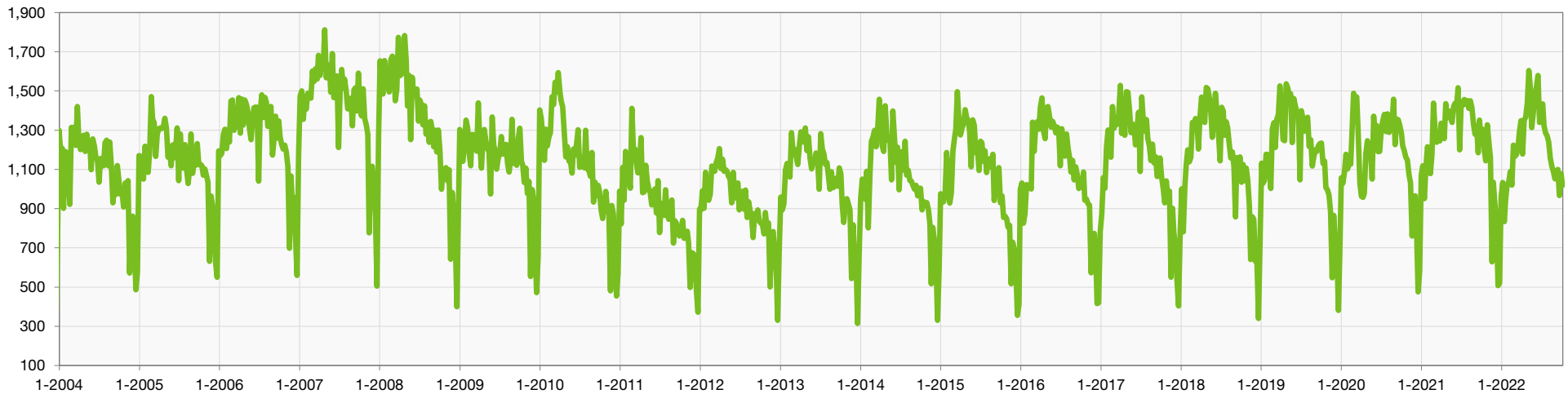

Historical New Listing Activity



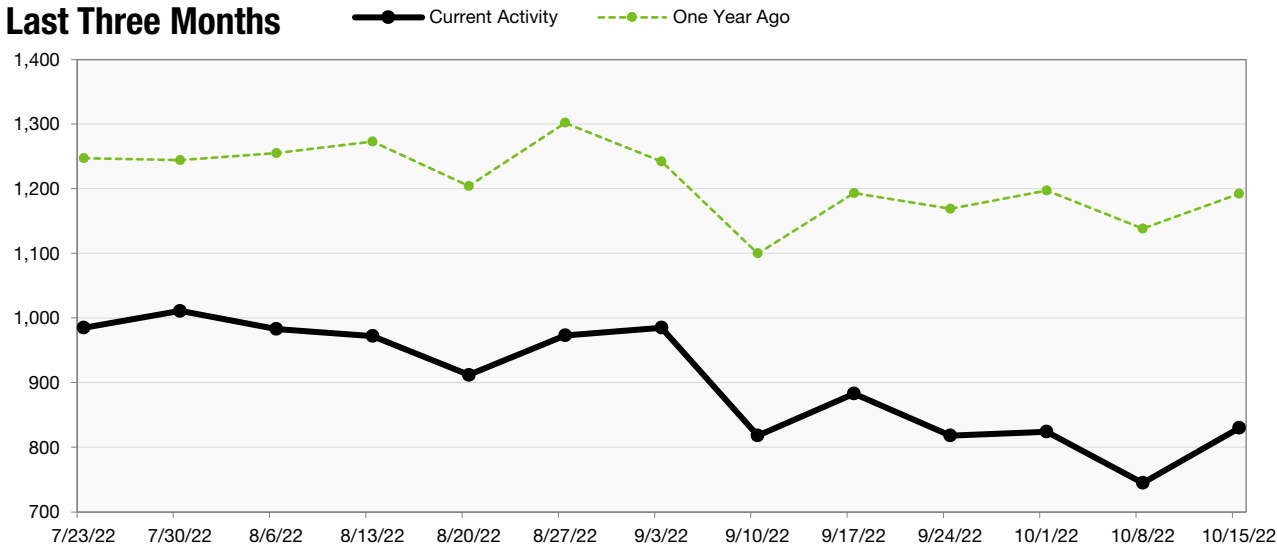

A count of the properties on which contracts have been accepted in a given week. Pending contracts include "Under Contract-Show" and "Under Contract-No Show" statuses.

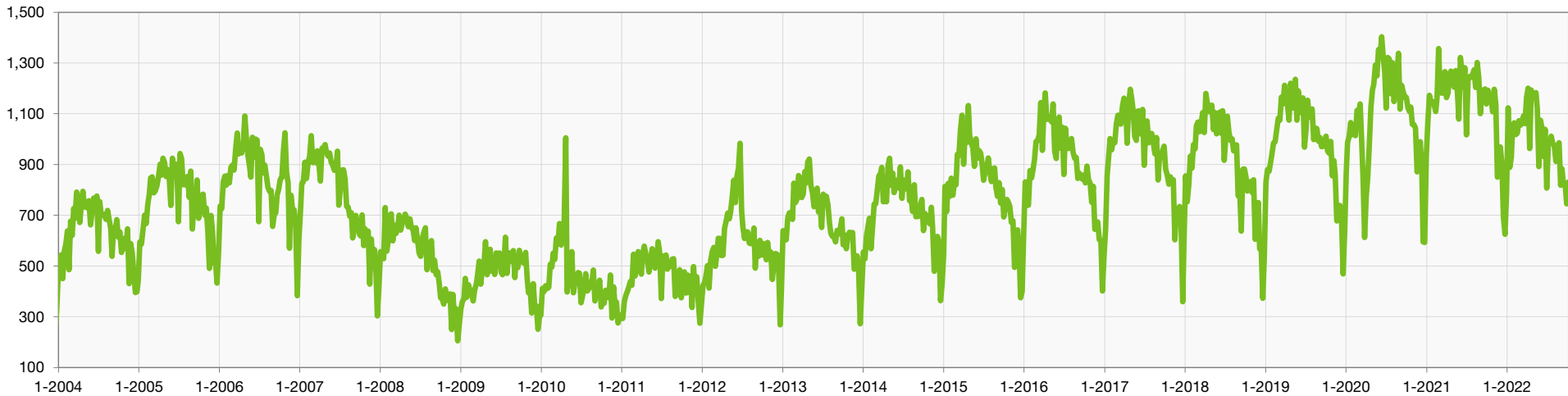

Historical Pending Sales Activity



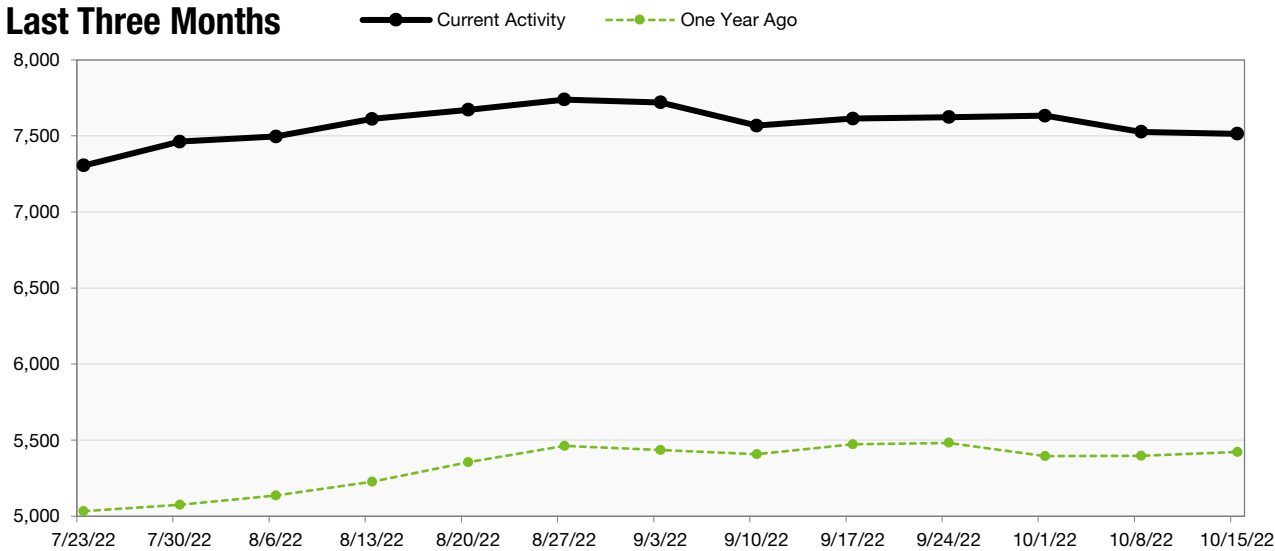

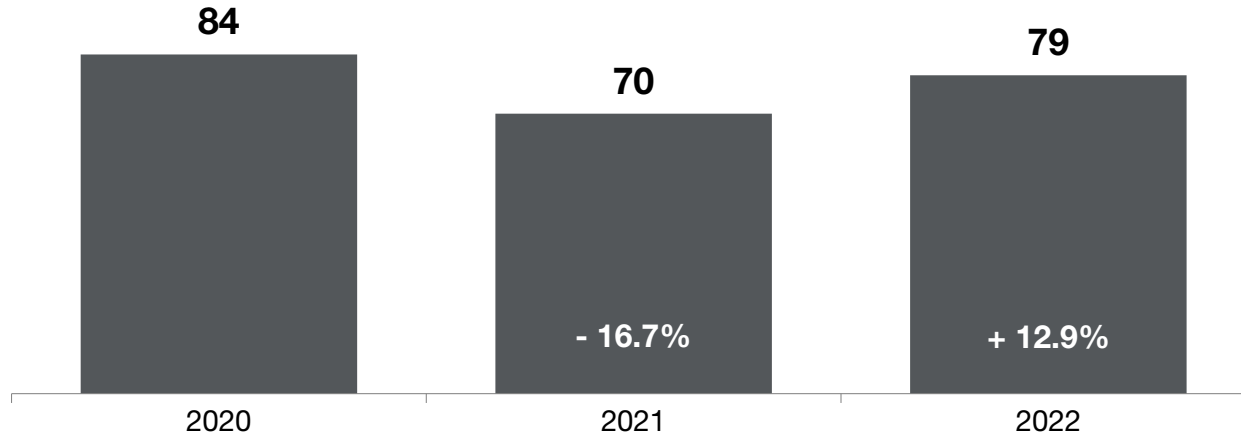

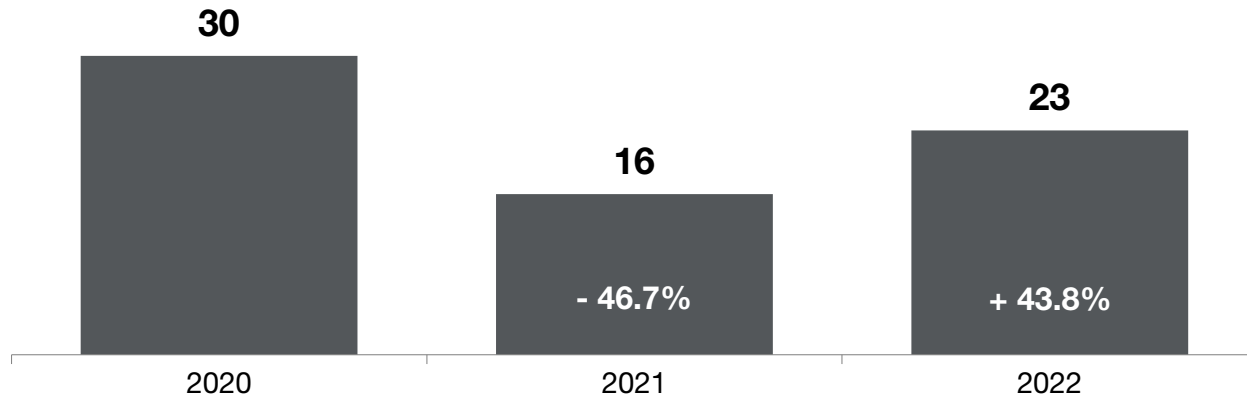

Days on Market (DOM) tracks the days on market for a property specific to the MLS number. DOM accrues for "Active" and "Under Contract-Show" statuses. DOM does not include any days that the listing is in "Under Contract-No Show," "Temporarily off Market," "Closed/Sold," "Expired" and "Withdrawn" statuses.

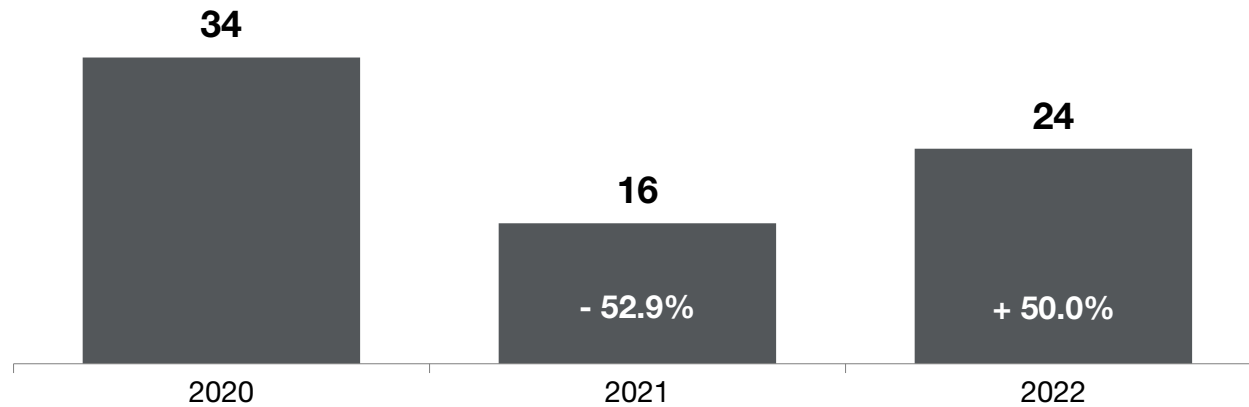

Cumulative Days on Market

Cumulative Days on Market (CDOM) functions like Days on Market (DOM); except CDOM tracks the DOM for a property over multiple listings on the property. When a new listing is entered, the CDOM only resets to zero if the previous listing closed (sold) or if the previous listing has been off the market (expired or withdrawn) for more than 90 days.

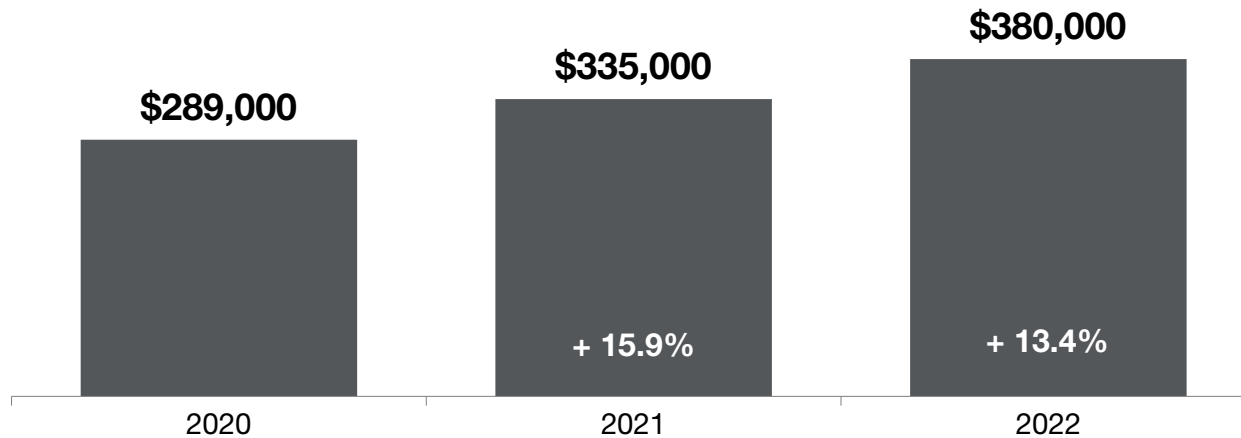

Median price point for all closed sales, not accounting for seller concessions, in a given month.

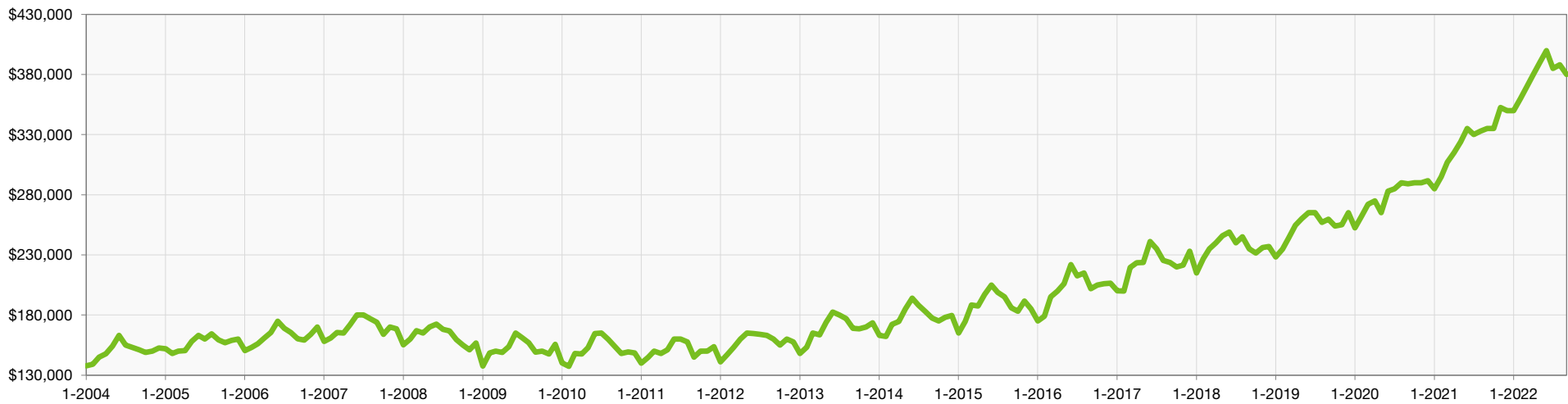

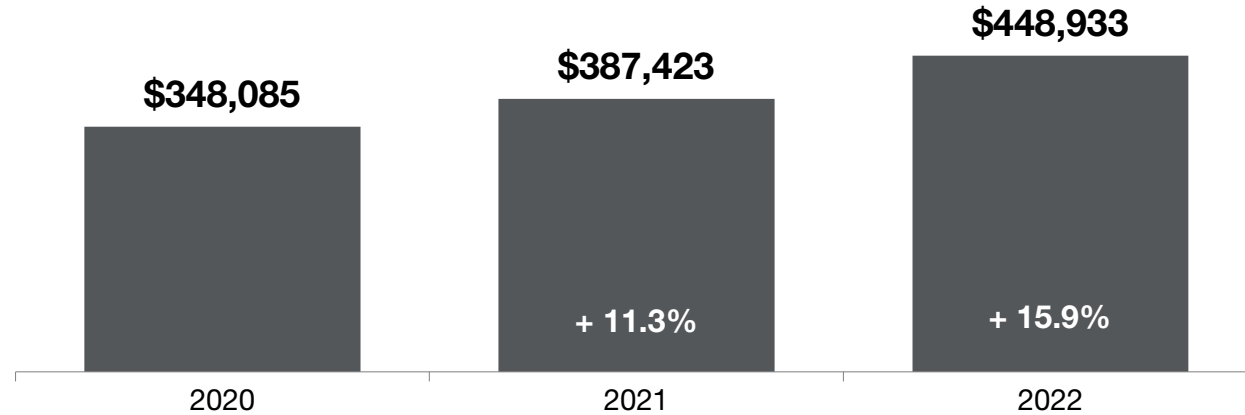

Average sales price for all closed sales, not accounting for seller concessions, in a given month.

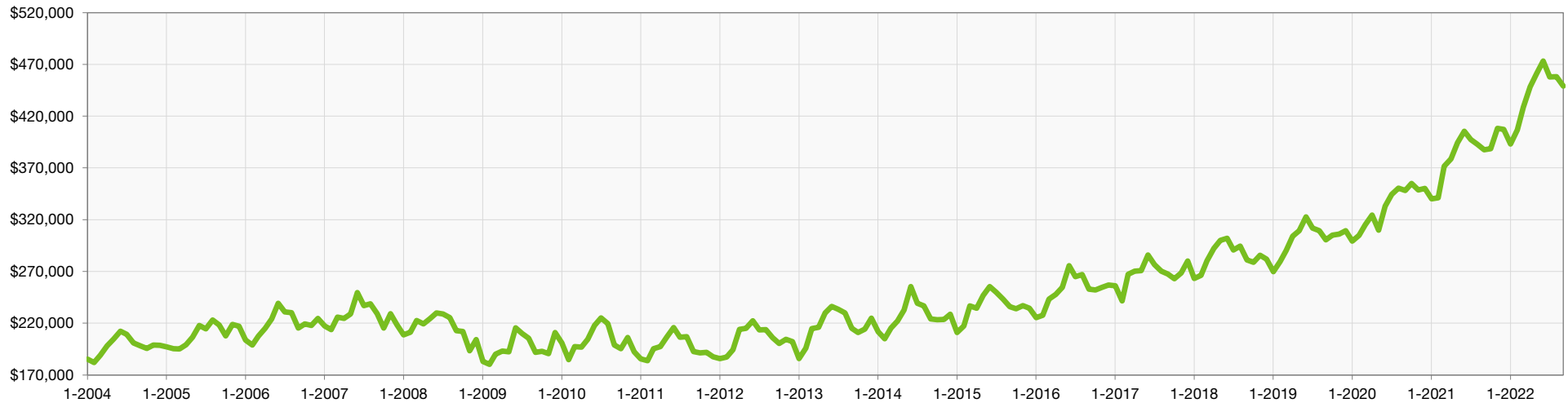

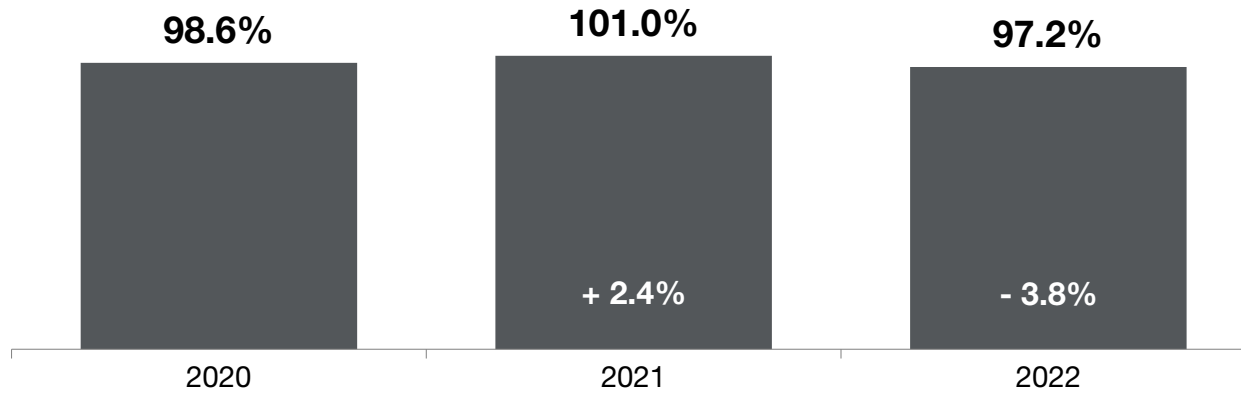

Historical Percent of Original List Price Received



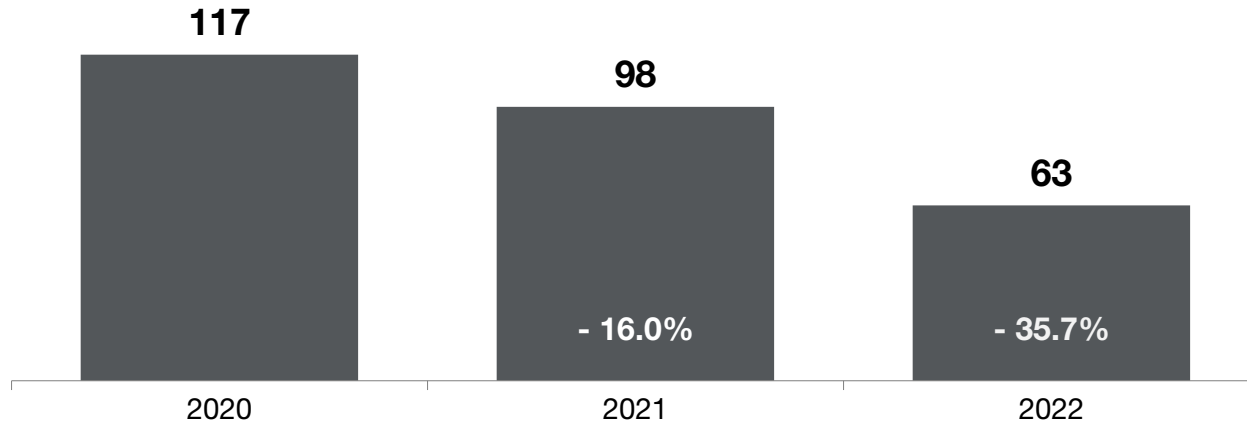

Housing Affordability Index

This index measures housing affordability for the region. For example, an index of 120 means the median household income was 120% of what is necessary to qualify for the median-priced home under prevailing interest rates. **A higher number means greater affordability.**

Historical Housing Affordability Index



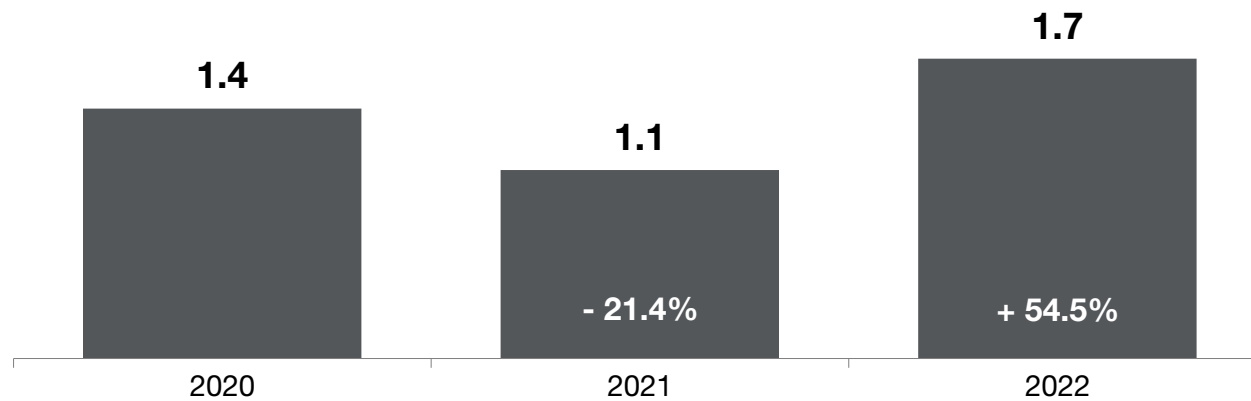
